We would like to inform you of a significant change in our business structure. On Sept. 14, 2022, Danaher Corporation initiated a spin-off to form a new company named Veralto, segregating its Environmental and Applied Solutions segment.

As a result of this separation, **the original Danaher water quality business in Singapore, primarily Hach, Trojan/Aquafine, will continue as an independent entity named HACH WATER QUALITY (Singapore) Pte Ltd.** ("HACH Singapore"). HACH Singapore, a subsidiary of Hach global, now falls under the umbrella of Veralto's operational companies.
